



## RESPONDING TO STUDENTS: CAMPUS SEXUAL ASSAULT

### STEP-BY-STEP GUIDE FOR FACULTY AND STAFF IF A STUDENT DISCLOSES A SEXUAL ASSAULT

#### STEP 1: CARE FOR THE STUDENT

- Offer nonjudgmental support and ensure that they are safe
- Encourage student to get medical attention
- Offer Student Support Services
- Disclose to student that you are a mandated reporter

### SURVIVOR'S REPORTING OPTIONS

**Sexual Assault** is any sexual contact or behavior that occurs without consent of the recipient of attempted rape, groping and forced kissing. North Carolina Agricultural and Technical State University prohibits all forms of sexual harassment and sexual misconduct including:

- Sexual assault
- Sexual exploitation
- Stalking
- Voyeurism
- Exposure
- Video or audio taping sexual activity
- Sexual activity resulting from emotional coercion

N.C. A&T is required by law and University policy to investigate complaints or sexual misconduct/assault to ensure a fair, effective, and comprehensive response to complaints, to protect each individual who is affected, and prevent further sexual misconduct/assault. Common steps in a investigation include, but are not limited to, determining a violation, interviewing the victim and accused, refer the investigative findings to the student conduct process, and ensure corrective measures as appropriate.

### ***MEDICAL ASSISTANCE (Confidential)***

- Students can go to Cone Wesley Long Hospital, 336-832-1000, for medical services
- A free Sexual Assault Exam is available at Wesley Long. The exam includes preventive treatment for sexually transmitted infections, pregnancy, and evidence collection. The exam is conducted by a Sexual Assault Nurse Examiner (SANE) who is a Registered Nurse with advanced training and certification in conducting sexual assault exams.
